Chondrodystrophy And Intervertebral Disc Disease Risk (CDDY-IVDD)	A	(CLEAR/NORMAL): These dogs have two copies of the normal gene and do not possess the mutation that leads to shortened legs and increased risk for intervertebral disc disease.
Chondrodysplasia (CDPA)	A	(CLEAR/NORMAL): These dogs have two copies of the normal gene and do not possess the mutation that leads to shortened legs.
Hereditary Cataracts (HC)	A	(CLEAR/NORMAL): These dogs have two copies of the normal gene and will not develop HSF4 hereditary cataracts.
PROGRESSIVE RETINAL ATROPHY ROD-CONE DYSPLASIA 4 (PRA-RCD4)	A	A (CLEAR/NORMAL): These dogs have two copies of the normal gene and will neither develop Progressive Retinal Atrophy Rod-Cone Dysplasia 4 nor pass this mutation to their offspring.
